Planning Appeal The Penthouse, 23 Prince Albert Road, NW1 7ST.

On behalf of Mr and Mrs Leslau ('the appellants'), Planning Resolution Ltd submit an Appeal against refusal by London Borough of Camden of planning application ref:2023/2589/P for the 'Erection of a glazed extension to flat roof of building, enclosure of 2 x existing balconies at seventh floor level to form internal space, erection of new balcony at seventh floor level within alcove, and associated alterations including replacement of brick balustrading with panelling at sixth and seventh floors' on 28th February 2024.

As identified in Paragraph 1.11 of the Appeal Statement, the planning application was subject to a preapplication enquiry submitted in April 2023 (ref: 2023/1709/PRE). This scheme showed open metal railings replacing the existing brick parapets too the 6th and 7th floor balconies.

The Council in their formal pre-application advice issued on 22nd August 2023, in part stated that in the Council's informal view that 'the replacement of the brick parapets to the 6th- and 7th-floor balconies with open metal railings would be 'detrimental to the overall appearance and coherency of the property, exacerbating the negative contribution that the building makes to the conservation area.'

As such, in seeking to address this comment the planning application proposed solid Corten steel balustrades. However, the appellant would be happy to revert to open metal railings in place of the Corten steel should the Inspector prefer this option and have submitted an alternative design including the railings with this appeal for consideration. We believe the minor amendments comprising either the option of Corten Steel or open metal railings accord with The Wheatcroft Principles, in that they are not vastly different from that originally submitted and do not prejudice any party.

In addition, having undertaken and submitted Accurate Visual Representations (Views 1 to 4) in support of the planning application, the appellants have undertaken further Accurate Visual Representations (AVR's) to specifically address the additional views that were raised in the Planning Officer Delegated Report where the proposed development was suggested as being particularly visible. i.e. those 5 additional views (views 5 to 9) beyond those contained in our initial submitted document.

All 9 views/AVR's are contained in a new document titled 'Representative Views and Methodology Part 1 and Part 2.' Which is submitted in support of this Appeal. This document also provides AVR's of the alternative railing balustrade option where visible in views. Again, we believe this accords with The Wheatcroft Principles, in that their submission seeks to positively address the Councils expressed concerns, are submitted as part of the Appeal enabling appropriate review and comment from The Council, and do not prejudice any party.
