T1- London plane- Take tree back to primary pollard points (reduction by roughly 10m in height and 8m in spread in each direction, tree is too large for the space especially when so close to 91a King Henrys Road.

T2- London plane-Take tree back to primary pollard points (reduction by roughly 10m in height and 4m in spread in each direction, tree is too large for the space especially when so close to 91a King Henrys Road

T3- London plane-Take tree back to primary pollard points (reduction by roughly 10m in height and 6m in spread in each direction, tree is too large for the space especially when so close to 91a King Henrys Road

No survey has been carried out but there is extensive cracking throughout the property that looks as though it could be linked to subsidence. These trees are considerably closer to the property and a similar size to the trees that had a staged removal between St George's Terrace and Primrose Hill Road. Client is keen to retain the trees but at much smaller dimensions so taking them back to their original pollard point seems appropriate and inkeeping with the aesthetic of the area

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
