Identification of Tree(s) and Description of Works

Photo Ref: PH_001 - Cherry Tree

Removal of cherry tree identified on plan drawing reference SK_001 and photo PH_001. The tree in question will be too close to a proposed rear extension which is subject to a separate planning application to be submitted for refurbishment works and a rear extension to 17b Laurier Road NW5 1SD (refer to PL_002 Proposed GFL and LGFL Site Plan). The structural engineer has advised that removal of the tree several months prior to start of foundation works for the new extension is advisable. Furthermore the tree has suffered from a lack of pruning and has developed branches which extend horizontally and may ultimately impact the stability of the tree (refer to photo PH_001).

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ\;$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
