# Identification of Tree(s) and Description of Works

#### T16 - XL Plane

The crown of this tree is broken into x3 main stems (see attached pictures)

Stem 1 is showing severe die back from the tips, likely resulting from Massaria (circ 35% dead). This die back extends 5-6m Stem 2 is showing a similar level of decline and a sparsely foliated crown (circa 25% dead) Stem 3 currently is in full leaf. Some deadwood however is present.

Stem 1 is leaning toward and growing over the tarrmacked playground. Stems 2 & 3 overhang a play area with slides, climbing frame etc. with a high footfall.

We advise to crown reduce this tree by 6-7m on Stem 1. 4-5m on Stem 2 and a 4-5m selective reduction on the remaining tree, to retain shape.

This will make the tree safe, and assist in managing the decline of the tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
