X7 London Plane (G1): Re-pollard (approx. 3-4m regrowth)

Work is to protect the health and stability of trees to be retained on the site, and to ensure that a satisfactory standard of visual amenity is provided and maintained. All specified work is cyclical maintenance and within good arboricultural practice and husbandry.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
