Lime (T1) - Re-pollard back to previous most recent cuts. To let more light into the property and small courtyard garden. Apple (T2) (in garden of 115) - Reduce crown by 2m on all aspects. To let more light into the garden of number 117.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - $\circ\;$ adding other relevant features on the site (e.g. greenhouse, paths)
