Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
The tree is an overgrown immature Elder that has reached a height of approx 3 metres (marked T on the sketch). As it is within 3 meters from both houses, the roots are threatening the foundations. By mutual agreement we wish to chop down the tree to prevent further growth.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
