Identification of Tree(s) and Description of Works
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
The Egypt Exploration Society requests that One Housing Group are given permission to fell two London Plane trees in the rear garden of 8 Doughty Street. Their contact with the east wall of our own property is causing substantial and ongoing damage. This damage can only be mitigated by the removal of both trees (see report by Tamla Trees,03679R). A previous request was submitted by One Housing Group in 2020 but was objected to on the grounds that further investigations should be carried out. This was done on behalf of the Egypt Exploration Society and was attached as supporting documents with another application submitted in 2022 which was approved by the Council (2022/0419/T). One Housing Group have failed to remove the trees by the deadline imposed by the Council and so this is a further application for their removal including the same information provided in the 2022 application.
