Proposed Work:

CAR PARK (PUMP STATION): 1 x Elder (Sambucus nigra) (LZ00681) - Crown reduction back to fence line.

- 1 x Common Ash (Fraxinus excelsior) (LZ00683) Fell to ground level.
- 1 x Crimean Lime (Tilia x euchlora) (LZ02051) Crown lift to 2.5m, prune low epicormic back inside fence lime and raise lowest crown tips to 2.5m over footway.
- 1 x Hornbeam (Carpinus betulus) (LZ03492) Crown reduce lateral spread back to fence line at north.

CAR PARK (CUMBERLAND BASIN): 1 x Wild Cherry (Prunus avium) (LZ02033) -

Fell to ground level leaving stem as habitat monoxyle to ca. 2.5m - 3m height.

- 1 x Wild Cherry (Prunus avium) (LZ02038) Reduce low limb from 2m north, which grows up against crown of cherry 3037 by 3m.
- 1 x Wild Cherry (Prunus avium) (LZ02043) Fell to ground level.
- 1 x Wild Cherry (Prunus avium) (LZ02044) Reduce branch wounds at east (canker with decay) and west (large diameter pruning wound on upper surface) of pair of large limbs originating from ca. 2.5m south-east sweeping towards car park drive, possibly pre-disposing failures -reduce branch structure of the two limbs by 2m 2.5m.
- 1 x Common Ash (Fraxinus excelsior) (LZ03409) Fell to ground level.

1 x Elm (Ulmus sp) (LZ03410) - Re-pollard.

1 x Elm (Ulmus sp) (LZ03411) - Re-pollard.

CAR PARK (PRINCE ALBERT ROAD): 1 x Norway Maple (Acer platanoides) (LZ02027) - Reduce branch structure upon two major scaffold limbs leaning towards and over railings by 2m - 2.5m.

1 x Hawthorn (Crataegus monogyna) (LZ03510) - Crown clean by pruning out broken bits, crossing/rubbing branches, low hanging branch near centre.

CAR PARK (CAMDEN END): 1 x Horse Chestnut (Aesculus hippocastanum) (LZ02015) - Fell to ground level.

The Council has considered your notification of intended works to trees dated 05 June 2024 and does not wish to object.
