NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA

Proposed Work:

REAR GARDEN: 1 x Sycamore (T1) - Reduce back to previous and most recent reduction points (approx. 1.5m - 2m). Thin crown density by up to 20%. Remove epicormic growth.

3 x Sycamores (T2, T3 & T4) - Reduce crowns back to previous reduction points approx. 2m - 2.5m, reducing newer branches back to main branch structure. Thin crown density by up to 20%. Remove epicormic growth.

1 x Purple Plum (T5) - Reduce crown by approx. 1.2m all round. Thin crown density by approx. 20% - 25%.

1 x Lime (T7) - Thin crown density by 25%. Reduce crown by approx. 1.5m - 2m maintaining a strong secondary branch structure.

The Council has considered your notification of intended works to trees dated 10 June 2024 and does not wish to object.

Informative(s):

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.

- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
