G1: Multi stemmed Chines privet shrubs (in planter): Approximately 3.00m: Fell all to ground level and treat with systemic herbicide. To allow Acer to flourish and re-use planter bed.

T1: Mature Acer: Approximately 4.00m: Thin crown density throughout by approximately 20%. General maintenance.

T2: Ginkgo: Approximately 2.50m: Fell to ground level. To allow acer and Ginkgo trees adjacent to flourish.

T3: Judas tree: (Multi-stemmed): Approximately 3.00m-4.00m: Remove minor front stems overhanging the garden space. Thin crown density by approximately 20%. Reduce over extended branches (top prune) back into main crown structure approximately 0.50m to central crown height and spread. General maintenance/Control encroachment.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
