Proposed Work:

FRONT GARDEN: 1 x Lime (T1) - Crown reduce to previous pollard points (approx. 1.5m height and 1m spread).

Leylandii (see plan) - Crown reduce height to 1st floor window (approx. 3m). Reduce spread to shape and balance (approx. 1m).

1 x Lime (T2) - Crown reduce to previous pollard points (approx. 1.5m height and 1m spread).

1 x Lime (T3) - Crown reduce to previous pollard points (approx. 1.5m height and 1m spread).

1 x Lime (T4) - Crown reduce to previous pollard points (approx. 1.5m height and 1m spread).

1 x Lime (T5) - Crown reduce to previous pollard points (approx. 1.5m height and 1m spread).

SIDE GARDEN: 3 x Limes (T7, T8 & T9) - Crown reduce to previous pollard points (approx. 1.5m height and 1m spread).

1 x Cherry (T10) - Crown reduce height and spread back to previous reduction points (approx. 0.8m height and 0.5m spread).

REAR GARDEN: 1 x Sycamore (T11) - Crown reduce height and spread back to previous reduction points (approx. 2m height and 1.5m spread) leaving soft furnishing growth.

1 x Ash (T14) - Crown reduce height and spread back to previous reduction points (approx. 1.5m height and 1m spread) leaving soft furnishing growth.

1 x Ash (T16) - Crown reduce height and spread back to previous reduction points (approx. 1.5m height and 1m spread) leaving soft furnishing growth.

The Council has considered your notification of intended works to trees dated 18 June 2024 and does not wish to object.

Informative(s):

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
