REAR GARDEN: 1 x Magnolia (T1) - Reduce by 30cm overall canopy.  
2 x Acer (T2) - Formative pruning 30cm for 4 branches.  
1 x Holly (T3) - Reduce height by 1m.  
1 x Amelanchier (T4) - Reduce canopy by 30cm.

The Council has considered your notification of intended works to trees dated 19 June 2024 and does not wish to object.
