Proposal:

(TPO REF: 23H-T50) FRONT AREA: 1 x London Plane (T2) - Remove diseased branches as needed, entire canopy.

(TPO REF: C60-T52 & T60) REAR AREA: 2 x Limes (TG9) - Reduce spread of crown by trimming back live, over-extended branches as needed 1m - 2m length reduction, entire canopy.

The Council has considered your application dated 13 June 2024 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- 1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.

- 2 All work shall be carried out in accordance with the relevant recommendations of

British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).
