The site comprises a two-storey terrace house located on the south-eastern side of Burrard Road. The building has an existing two storey outrigger.

The property is not designated as a heritage asset as it does not lie within a conservation area, is not a listed building and is not restricted by an Article 4 direction, other than for basement excavation. It is within the Fortune Green and West Hampstead Neighbourhood Area, but this does not restrict permitted development.
