The application site meets both de minimis conditions. Plans E009 and E010 show that the site does not include any priority habitats (as listed in Section 41 of the Natural Environment and Rural Communities (NERC) Act 2006: habitats and species of principal importance in England), hence no onsite priority habitats will be impacted by the proposed scheme. The existing building is classified as developed land: sealed surface which has a biodiversity value of zero under the statutory biodiversity metric. The footprint of the existing building and rear courtyard will not be changed. Photographs of the existing courtyard can be found within the Design and Access Statement submitted alongside the application which shows there is no existing vegetation within the boundary of the site. For the reasons outlined above, we believe the proposed development is exempt from biodiversity net gain by the de minimis exemption.
