REASON FOR WORKS

The trees are overgrown and in close proximity to buildings and other structures. The work is intended to maintain the garden and is appropriate and in line with the industry best practice.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
