T1: Robinia (14m): Fell due to bifurcation and fused branches, tree 4m from building. Due to the trees location and the bifurcation, the tree needs repeated reduction work which is resulting in an unsightly tree and the client wishes to fell and re-plant with a more suitable species. Client wishes to plant an Acer Campestre with a height of 3m-4m.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
