Trees is garden need crown lifting and selective pruning around security camera.

Team to pollard Lime tree removing approximately 3 meters from the height and 2 meters from the laterals and lift the canopy up to the crown break (T1)

Team to reduce Sycamore tree removing no more than 2 meters from the height and 1.5 meters from the laterals leaving appropriate growth points at the ends of the branches (T2)

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
