Scope

Trees in garden need crown lifting and selective pruning around security camera

Method

- Team to attend site and access external areas and carpark
- Team to pollard Lime tree removing approximately 3 meters from the height and 2 meters from the laterals and lift the canopy up to the crown break (T1)
- Team to reduce Sycamore tree removing no more than 2 meters from the height and 1.5 meters from the laterals leaving appropriate growth points at the ends of the branches (T2)
- Team to use chainsaws and chipper to process waste
- All generated green waste to be removed from site to a recognised waste facility

Risk / Clarification

1. If trees are subject to a Tree Preservation Order (TPO) or are situated within a Conservation Area, consent will be required from the Local Planning Authority before works can commence. We would make any TPO applications on your behalf as part of the works.

Works to neighboring trees will require the owner's written permission in advance before works can begin.

2. The Local Planning Authority have 14 working days to validate the application upon submission, if any information is incorrect or they require any further clarification of works we will advise.

Once the application has been validated you will receive a decision date. There could potentially be a 6 week wait for works that fall within a Conservation Area and a 8 week wait for works that fall under a Tree Preservation Order. Please bare in mind that these dates may change due to further information required, delayed access for tree/planning officers to gain site.

3. With any tree or shrub works, Ground Control must ensure that no nesting birds are disturbed under the Wildlife and Countryside Act 1981, Countryside and Rights of Way Act 2000 and the European Habitats Directive 1992/Nesting Birds Directive. The 'Bird Nesting Season' is from March until August inclusive. If any works are requested to be carried out within these months we will perform bird nesting checks prior to the work commencing. If active nests are found, the tree/shrubs must not be worked on and we will inform you of this immediately

Exclusions

1. Any works not identified in this report
2. Current boundary lines are marked within the fence line. Any areas outside of the marked boundary lines will be classed as additional areas unless agreed prior to commencement.
