METAL BALUSTRADE TO THE REAR LIGHTWELL WITH THE WINDOW TO BE RAPLACED BY HORIZONTAL METAL GRILLE. RENEWED REFUSE AND RECYCLING BIN ENCLOSURE TO THE FRONT.
