It is proposed to construct an additional storey on the existing residential property at 58 Hawtrey Road, NW3 3SS, in line with the standards set out within Class AA, Schedule 2, Part 1 of the GPDO. The proposed additional storey would be constructed on the principal part of the existing dwelling house.

The additional storey would accommodate two bedrooms and a bathroom. In line with the requirements, no windows will be located on the

elevations of the additional storey. Additional windows will be located in the front and rear elevations in order to provide the new bedrooms with good levels of light. The total height of the additional storey, at approximately 2.9 metres, falls well within the parameters set by the Guidance. The alteration was required to comply with the rules of the Chalcot Estate.

Please describe the effects of the proposed development on the external appearance of the building including the design and architectural features of the principal elevation (and any side elevation that fronts a highway)

As shown on the accompanying drawings SD2422(P)01-A and SD2422(P)21, the materials for the additional storey have been carefully selected in order to match the materials of the existing house. The brickwork and render have been designed to match the existing materials. The additional storey once constructed should be seen as a natural extension to the existing building and not as a separate element. The erection of an additional storey will not result in any further impact on neighbouring amenity. This is very much in line with the previously granted application within the vicinity of the area.

Due to its location, the additional storey will not take any significant amount of daylight or sunlight from the neighbouring buildings. The existing distance between the buildings to the front and to the rear ensures privacy.

In the case of upwards extensions consideration must be given to every face of the building

The proposal of an additional storey will have a windows at the front and back which will have no adverse effects on the neighbours. Due to its location the additional storey will not take any significant amount of daylight or sunlight from the neighbouring as the existing current windows for this property and adjacent properties are at the west and east sides of the elevations. This will not change the impact as its currently received by the neighbours.

The existing distance between the buildings to the front and to the rear ensures the privacy.
