T1: Mature Sycamore - (located near to the first corner of Regal Lane at the rear of No.3 Regents Park Road):

Reduce over extended branches back into main crown structure by approximately 1.50m. Thin rear section of the crown (where it is most dense) by approximately 20-25%. Thin front section of the over the lane by 10-15%. Reduce lateral and sub lateral braces growing over the lane by approximately 1.50m to clear Birch and control encroachment. Remove major dead wood throughout crown. Remove dead vine.

Reason/s: General maintenance to help control encroachment over neighbouring property.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
