Poor gordon:	
Rear garden: Hornbeam T1 (18M high, 500mm dia.) - scaffold pollard slightly lower than previously in 2022 application at 6 to 7 metres, maximum cut diameter of 200mm. Tree is causing excessive light loss to a narrow garden and exhibiting good regrowth. Tree is on south boundary. Hornbeam T2 (18M high, 500mm dia.) - scaffold pollard slightly lower than previously in 2022 application at 6 to 7 metres, maximum cut diameter of 200mm. Tree is causing excessive light loss to a narrow garden and exhibiting good regrowth.	

Holly H1 - 4 trees (12M high,250mm x4 dia.) - overgrown hedge reduce down to 6 metres high.
