				One sign on each of the three masonry faces would be quite sufficient to indicate the name and purpose of the shop. To show one in each window and door is ill-considered in the extreme.
				The proposed signs do not take into account the character and design of the property, or the appearance of its surrounds and location in Belsize Conservation Area. They would dominate the ground floor of the building and would be a dominant feature in the setting of the building in the CA, which would be exacerbated by its location. They would adversely impact upon amenity and would not be sympathetic to the host building (which is residential) and surrounding environment. They are excessive in number, and with the vinyl graphics applied to the windows would obstruct views into the shop and create clutter which would have a negative impact on the amenity of the CA. The signage would not preserve the character and amenity of the area.
				The Camden Local Plan 2017 policy D3 para 7.80 states that 1The Council discourages shop window displays and graphics that completely obstruct views into the shop' (for example vinyl graphics applied to the window). Clause 1.11 of The Camden Planning Guidance: Advertisements March 2018 states that IAny advertisements, of whatever type, on or near a listed building or in a conservation area must not harm their character and appearance and must not obscure or damage specific architectural features of buildings).
