## Front Garden:

T1: Mature Horse Chestnut: Approximately 19.00m: Thin whole tree by approximately 20-25%. Remove major dead wood throughout crown. Remove broken branches. Reduce low lateral and sub lateral limbs growing to the east of the crown, toward and overhanging the roof by approximately 2.50m-3.00m to provide sufficient clearance and increased light levels. Remove epicormic growth. Raise crown over pavement by 1.00m. General maintenance and control encroachment.

T2: Beech: Approximately 16.00m: Thin crown density evenly throughout by 20%-25%. Remove 1 x low branch (approximately 15cm diameter) which is low over car parking area. Reduce crown back from the building by approximately 2.50m-3.00m, to provide sufficient clearance. Remove dead wood. Reduce over long extraneous branches back into main crown structure by approximately 1.50m. General maintenance, control encroachment.

T3: Ash: Approximately 9.00m: (Near pedestrian gate): Thin crown density throughout by 20%. Remove dead wood and broken branches. Raise low crown by 1.20m-1.50m.

T4: Birch: Approximately 8.00m: (Over main gate): Raise crown to clear gate by approximately 1.00m. Thin crown density by approximately 15%. General maintenance, control encroachment.

#### Side garden:

T5: Olive: Approximately 5.00m: Reduce crown by approximately 1.20m to help lower grown regeneration. General maintenance.

T6: Cotinus: Approximately 4.00m: (Overhanging from corner garden): Reduce low lateral limb by approximately 1.20m: General maintenance.

## Rear Boundary:

T7 Olive: Approximately 5.00m: Reduce crown by approximately 0.75m to shape and tidy. General maintenance.

G1: Group of 3 x Sycamores: Approximately 13.00m: Reduce back to previous and most recent pollard points. General maintenance.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

## Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - o mark and name surrounding roads
  - $\circ\;$  sketch in buildings, including adjoining properties
  - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
