Identification of Tree(s) and Description of Works
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
(T1) Apple - This tree is situated approximately 6m from the rear of the building. Proposed building works will mean that the property is too close to the tree and works will damage roots. My client is proposing the tree is removed before building work takes place. They are happy to replant in a more suitable location.
(T2) Sycamore - This tree was pollarded approximately 8 years ago. Proposing to reduce tree back to previous pruning points, up to 5m in order to prevent failure of branches at weakened unions
(T3) Ash - This is the tree that has a TPO on it. It is situated in adjacent garden to rear. The tree is very mature and limbs have become very overextended. Movement of ground and falling branches have caused damage to garages underneath the tree. The tree has 3 codominant stems, proposing to remove one stem, which overhangs garden/garages of number 40. This is to mitigate risk of failure and prevent further damage to garages
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
