#### 2. HERITAGE CONTEXT

# CONSERVATION AREA

The Mansfield Conservation Area, established on 11th September 1990, is characterised by its Victorian and Edwardian architecture. It falls within Gospel Oak, located between Hampstead, Maitland Park, and Kentish Town on the edge of Hampstead Heath. The area is noted for its tree-planted streets and uniform late 19th-century urban residential development.

## 3. ARCHITECTURAL SIGNIFICANCE

# BUILDING DESCRIPTION

106 Fleet Road is a more modern building surrounded by late 19th-century terraces that contribute to the area's more traditional commercial and residential mix. The building doesn't feature the traditional York stone paving to the front forecourt area. It also does not mimic either the two story terrace or three story terraces either side that have decorative corbels, fascias and sliding sash windows. The building seems to be a more modern connecting the traditional terraces either side

# SURROUNDING BUILDINGS

The neighbouring buildings are primarily late 19th-century terrace houses and commercial properties with similar architectural styles, contributing to the cohesive character of Fleet Road. Notable structures include the White Horse public house, which marks the west end of the road with its prominent late 19th-century red brick facade and decorative elements.

### 4. IMPACT ASSESSMENT

### **VISUAL IMPACT**

The new roller shutter and illuminated sign have been designed to match the existing shopfront's style and colour scheme, ensuring minimal visual intrusion. The shutter will be finished in a colour that complements the existing facade, and the sign will use energy-efficient LED lighting, with a design echoing traditional signage.

# HISTORICAL INTEGRITY

The proposed changes are respectful of the building's historical character and do not involve any alterations to any significant architectural features. The addition of the shutter and sign will not affect the locally listed buildings, period features, or distinctive attributes.

# MITIGATION MEASURES

To mitigate any potential negative impacts, the materials and colours used for the shutter and sign will match the existing facade, and the installation will be reversible.

### 5. COMPLIANCE WITH CONSERVATION POLICIES

#### **LOCAL POLICIES**
