REAR GARDEN: 1 x Bay Laurel (Laurus) (T1) - Crown reduce by 3m - 4m back from adjacent property.

1 x Cherry Plum (Prunus) (T2) - Fell to ground level.

1 x Ash (Fraxinus) (T9) - Crown reduce 2m.

1 x Acer (T10) - Lift to 3m above the road and prune back to kerb line. 1 x Yew (T12) - Lift to 3m above the road and prune back to kerb line.

FRONT GARDEN: 1 x Bay Laurel (Laurus) (T3) - Fell to ground level.

1 x Laburnum (T4) - Crown reduce by 1m.

Group of self-set Ash (Fraxinus) (G1) - Reduce by 1m.

SIDE GARDEN: 1 x Ash (Fraxinus) (T5) - Fell to ground level.

- 1 x Ash (Fraxinus) (T6) Fell to ground level.
- 1 x Horse Chestnut (Aesculus) (T7) Crown reduce by 1m.
- 1 x Ash (Fraxinus) (T8) Crown reduce 2m.

Group of self-set Ash (Fraxinus) (G2) - Fell to ground level.

It is evident that the applicant would like to manage the trees responsibly and in general, we have no objection to this application with one major exception; the felling of the Bay Laurel.

In our experience a Bay Laurel growing close to a structure has little or no effect; witness the Bay Laurels growing at the front of Cromwell House, a grade I listed structure. Removing the tree would have a significant impact on the visual amenity of the area, particularly as at least one of the large, old trees has fallen and the replacement is still very young.

The effect of the lack of trees and vegetation to the front of the houses, can clearly be seen at numbers 12 and 13.

We might hope that the gap left by filing T5 and T6 will be quickly filled by the adjacent trees but we would like the Tree Officer to assess the suitablilty of planting replacement trees.

(TPO REF: C7-T29) REAR GARDEN: 1 x Holly (T11) - Lift to 3m above the road and prune back to kerbline.

Three metres above the road seems excessive and would spoil the form of the tree.
