T1 Sycamore: Requires a reduction of all aspects by 2 to 3 meters. This action is necessary to manage its overall size and spread, thereby containing root activity. The roots are currently causing issues with the adjacent fence. Despite not yet reaching maturity, the tree is notably large for a small suburban garden. It has pockets of decay, and the proposed reduction will enhance structural integrity and mitigate potential storm damage. Additionally, this reduction will allow more light into the garden, thereby improving its usability.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
