Proposal:  
(TPO REF: 24H-T52) FRONT GARDEN: 1 x Lime (T1) - Reduction of crown to previous reduction points around 2m - 3m to be removed leaving the tree around 14m - 15m. Remove all epicormic growth from ground to 3m to clear footpath.
