- Reduce live branches as needed, 1-2 metres length reduction, entire canopy trimtop and sides to maintain size and shape

T2 Pittosporum left side of property rear garden

Goals:

Reduce spread of crown

• Reduce over-extended branches as needed, 1-1.5 metres length reduction, growing toward and over neighbours roof

Goals:

- Reduce crown height
- Reduce spread of crown
- Reduce live branches as needed, 1-2 metres length reduction, center of canopy
- Reduce live, over-extended branches as needed, 0.2-0.5 metres length reduction, lower canopy

T4 Laburnum Central Garden area

Goals:

- Reduce size of crown height and spread
- Remove disease dead wood
- Reduce all live branches, 0.5-1 metres length reduction, entire canopy
- Remove all dead branches, entire canopy

Species Location

T5 Crabapple right side of property rear garden

Goals:

- Remove disease dead wood
- Reduce crown height
- Reduce density
- Remove all dead branches, entire canopy
- Reduce all live branches, 1-2 metres length reduction, Hight and prune sides to balance form

Species Location

T6 Juniper left rear of property

Goals:

- selectively prune
- Remove dead branches

• Reduce over-extended branches over path way cut back by hand pruning branches as needed, growing toward and

over path

· Remove dead branches as needed, center of canopy

Species Location

T7 Pear back of property

Goals:

- Remove disease dead wood
- T8 Elderberry back of property

Goals:

- Reduce size of crown height and spread
- sever ivy and remove as much as possible
- Reduce all live branches, 1.5-2 metres length reduction, entire canopy

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

e.g. Oak (T3) - Whole crown reduction to 12m above ground level, to provide sufficient clearance to property.

Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - $\circ~$ add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ\,$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
