conclude that the proposal is unlikely to have a significant effect on heritage assets of archaeological interest.

The planning application lies in an area of archaeological interest (Archaeological Priority Area) identified in the Local Plan: [78218] London Suburbs

However, given the proposed works will be contained to the footprint of the existing basement and no new piling or underpinning is planned it is considered there is limited potential for encountering archaeological remains.

No further assessment or conditions are therefore necessary.
