Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

The development hereby permitted shall be carried out in accordance with the following approved plans and documents: Structural Engineering Report Ref. AMA-23--6-REP-01-REV 02, Ground Movement Assessment (Buildings Damage) Report dated 29 January 2004, Ground Investigation & Basement Impact Assessment Report dated 21/11/2023, Geotechnical Assessment & Basement Impact Assessment Report dated 21/11/2023, 00-401-P03, 221-00-220, 00-210-P03, 00-210-P04, 00-400-P02, 00-201-P04, 00-2401-P02, 98-210-P02, 98-201-P02

Reason: For the avoidance of doubt and in the interest of proper planning.

3 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 and D2 of the London Borough of Camden Local Plan 2017.

The development shall not be carried out other than in strict accordance with the methodologies, recommendations and requirements of the Basement Impact Assessment (Basement Impact Assessment and associated documents Ref. AMA-23066-REP-01 Rev 02 Jan 2024 Audited March 2024]) hereby approved, and the confirmation at the detailed design stage that the damage impact assessment would be limited to Burland Category 1.

Reason: To ensure proper consideration of the structural stability of neighbouring buildings and to safeguard the appearance and character of the immediate area in accordance with the requirements of policies D1, D2 and A5 of the London Borough of Camden Local Plan 2017.

The appointed engineer Christos Christou BEng CEng MISTructE of AMA Consulting Engineers shall inspect, check for compliance with the design (as approved by the local planning authority and building control body) and monitor the critical elements of both permanent and temporary basement construction works throughout their duration. Any subsequent change or reappointment shall be confirmed forthwith for the duration of the construction works.
