Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T112 mature Hawthorn in eastern planted beds, with evidence of advanced decline

- Dismantle to near ground level
- Grind out stump to approx. 250mm below ground level using guards to control the spread of flying debris

T25 Catalpa within lawn area near western avenue with excessive deadwood noted throughout canopy

- Using on site MEWP due to unsuitability to climb and using rope and harness canopy access techniques, remove major deadwood
- T113 Purple leaved plum in eastern tree line with over protruding canopy shape and encroaching towards building
- Sensitively reduce canopy by the use of 'drop crotch' pruning of over protruding canopy dimensions back into the internal framework (effectively reduction of longer branch ends by approx. 1.5-2m
- Lift low crown all round to an even level to approx. 4m over ground

T56 Cedar of Lebanon which had suffered recent branch failure

- Sensitively lift low hanging crown to approx. 1-5m above ground (exact extent to be agreed with site managers) to neat and even level all round
- Climb tree to remove major deadwood including crowded and crossing branches
- 2 x Deodar cedar in NW corner of garden (1 x near western avenue and 1 x near building)
- Sensitively lift low hanging crown to approx. 1-5m above ground (exact extent to be agreed with site managers) to neat and even level all round

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
