Pittosporum (T001) - Fell. Implementation of planning permission ref: 2022/4555/P has resulted in the undercroft lobby being extended beneath the stem of the Pittosporum, which has resulted in the severance of multiple structural roots, those measuring above 25mm in diameter, as shown in the photographs. In addition, the Pittosporum is located atop a circa. 2m high retaining boundary wall to which it is starting to cause direct damage. As a result of damage to the Pittosporum's structural roots, it is considered that its safe future retention cannot be ensured. Its removal is therefore proposed.

Chinese Privet (T002) - Fell. The loss of the Pittosporum will leave this specimen with a notably asymmetric crown, thereby significantly diminishing its aesthetic value. It will also expose its crown to wind effects for which it is not adapted, therefore increasing the risk of wind throw or wind snap. The reduced stability of T002 following removal of T001 is exacerbated by its location atop a circa. 2m high retaining boundary wall. Its removal is therefore also proposed.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
