## 46-47 Bloomsbury Square, London, WC1A 2RA

On behalf of our client, Hogarth S.A.R.L., we are pleased to enclose an application for Listed Building Consent for works at 46-47 Bloomsbury Square, London, WC1A 2RA.

This application follows a recent approval of Full Planning Permission and Listed Building Consent at the property (LPA refs. 2023/0224/P & 2023/0882/L). Whilst the previous approvals secured permission for external and internal alterations and refurbishments, it has been brought to our attention that several of the detailed drawings submitted with the original application have not been referenced on the official Decision Notices.

The purpose of this latest application, therefore, is to regularise this discrepancy and re-provide the full suite of drawings, so that they can be captured in one Decision Notice for Listed Building Consent.

The full extent of external alterations was successfully captured in the previous approvals, so this application is just for Listed Building Consent and intended to ensure the full extent of internal works and finishes are also formally captured on one Decision Notice.
