Rear garden
T1 - Pear Tree — This old tree appears to be compromised at its root plate and appears unstable when climbed. There also appears to be a cavity at its base that could mean the centre is hollow affecting its structural intergrity - Due to its location - Fell to ground level.
T2 - Pear – Re-reduce back to previous reduction points by approx 1m

T3 - Box Elder – Re-reduce by approx back to previous reduction points by approx 2m

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
