| T1, Apple tree. Fell. This tree is quite old about 70/80 years. It has major decay holes in main trunk major deadwood throughout the canopy, and infestation of bugs in rot sections of the tree. The tree is now in a dangerous condition.  T2. Ash overall crown reduction by approximately 2m/30% back to previous pruning points. This would allow more light into small gardens and reduce risk of failure in high winds. |
