T1 Lime right side of property rear garden

Goals:

- · Remove disease dead wood
- · Reduce density
- · Reduce spread of crown
- Provide of clearance
- · Remove dead, declining branches as needed, entire canopy
- Reduce and/or remove 20 percent of live, rubbing branches, entire canopy
- Reduce interfering, over-extended branches as needed, 2 metres length reduction, growing toward neighbouring rear garden
- Remove live, interfering branches lift to a height of 4 Meters branches as needed, right hand side on trunck of the tree
- · Remove all debris

Specifications:

Arborist Notes:

• As looking at the tree from no 6 Prince Arthur Mews rear garden right hand side of tree is to be worked on and anything growing at the rear of the tree to let more sun light into neighbouring rear garden.

T2 Cherry right side of property rear garden

Goals:

- · Reduce size of crown height and spread
- Provide of clearance
- Reduce live, over-extended branches as needed, 0.5-1 metres length reduction, entire canopy
- · Remove two lowest branches as needed, left side of tree
- · Remove all debris

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o mark and name surrounding roads
 - o sketch in buildings, including adjoining properties
 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
