Calculations have been undertaken based upon the above, the updated layout illustrated in drawing 20024-DMB-XX-00-DR-A-A309-PL3, and assuming the same mitigation measures shown in table 5.3 of our noise impact assessment ref. VA4134.220510.NIA, and summarised below in Table 1.3.

The predicted cumulative noise level at the nearest receiver would be expected to still comfortably meet with Camden's planning noise limit of 39dB(A) set in the original noise impact assessment, and hence would comply with the requirements of condition 5 of the consent ref. 2022/3335/P, and hence also would accord with Policy A1 and A4 of the Camden Local Plan 2017.
