We would like to fell the first of the 3 Lime trees (tree closest to the property) as it has damaged the neighbours wall and has become too big

We would like to fell the first of the 3 Lime trees (tree closest to the property) as it has damaged the neighbours wall and has become too big for its location - the cracks can be seen in the photo attached (photo taken from neighbouring property). There is also a photo of how close the tree is growing against the wall. The other 2 trees growing next to it aren't as close to the wall. It will also allow more light in to the garden and property as they block any light coming through.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
