## DECISION

## **Full Planning Permission Granted**

Address: 14 Perrin's Court London NW3 1QS

Proposal: Refurbishment and alterations to shopfront. Drawing Nos: 001; 201.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 The development hereby permitted shall be carried out in accordance with the following approved plans:

001; 201.

Reason: For the avoidance of doubt and in the interest of proper planning.

3 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 and D2 of the London Borough of Camden Local Plan 2017.

Informative(s):

1 Reasons for granting permission:

The application property is a ground floor unit located at the northern side of Perrin's Court within the Hampstead Conservation Area. The application building is not listed but identified as a positive contributor to the special character and appearance of the conservation area. It is noticed that No.10 and 12 Perrin's Court are Grade II listed building.

The proposal would involve refurbishment and alterations to shopfront. Proposed works include replacement of two existing front extract vents with a new extract grille into existing fascia which will be painted to match shopfront paint colour which will be dark blue. Existing shopfront will be sanded sown and repainted to the brand colour. The low level grilles will be replaced with solid timber panels and the metal frames will be removed.

The proposed replacement extract grille is considered an improvement from the existing and better integrated into the fascia sign with matching paint colour to the shopfront. Overall, the proposed works to shopfront are minor in nature and would have limited visual impact to streetscene. It is therefore considered that the proposal would preserve the character and appearance of the host building, streetscene at Perrin's Court and Hampstead Conservation Area.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the conservation area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

In terms of amenity impact, given the nature and the scale of the proposed works, they would not cause any adverse impacts on the amenity of adjoining residential occupiers in terms of loss of light, outlook or privacy.

No objections were received following statutory consultation. The planning history of the site has been taken into account when coming to this decision.

As such, the proposed development is in general accordance with Policies A1, D1 and D2 of the London Borough of Camden Local Plan 2017, Policies DH1, DH2 and DH3 of the Hampstead Neighbour Plan 2018, the London Plan 2021 and the National Planning Policy Framework 2023.

Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must secure the approval of the Council's Noise and Licensing Enforcement Team prior to undertaking such activities outside these hours.
