Proposed Work:

ON STREET: 1 x Sycamore (T1) - Reduce over extended branches back into main crown structure by approx. 1.5m. Thin rear section of the crown by approx. 20% - 25%. Thin front section of the over the lane by 10% - 15%. Reduce lateral and sub lateral braces growing over the lane by approx. 1.5m to clear Birch and control encroachment.

The Council has considered your notification of intended works to trees dated 23 July 2024 and does not wish to object.
