REAR GARDEN: 1 x Hornbeam (T1) - Scaffold pollard slightly lower than previously in 2022 at 6m - 7m, maximum cut diameter of 200mm.

1 x Hornbeam (T2) - Scaffold pollard slightly lower than previously in 2022 at 6m - 7m, maximum cut diameter of 200mm.

FRONT GARDEN: 4 x Holly (H1) - Reduce hedge down to 6m high.

The Council has considered your notification of intended works to trees dated 23 July 2024 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
