EGB - Epicormic remove - to allow detailed inspection of base during annual survey.

T221 - Acer platanoides (Norway Maple), T218 & T223 - Acer pseudoplatanus (Sycamore) & T489 - Cerasus avium (Wild Cherry):

L00 - Lift low canopy, specified extent - to 4.5 m over driveway to east.

T488 - Tilia x vulgaris (Common Lime):

EGB - Epicormic remove - to 3 m, to facilitate a more detailed inspection of the base during future scheduled surveys.

 - showing the approximate distance between the application tree(s) and buildings
