## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T240 - Prunus cerasifera 'Pissardii' (Pissard's Plum):

RVL - Remove faulted limb(s) - heavily declining limb to the east at 2.5 m back to live upright mature epicormic stem 1.5 m out from the main stem union. Also remove any further deadwood throughout crown.

T244 - Malus sp. (Apple sp.):

RVL - Remove faulted limb(s) - (suspected fireblight) removing all dead and declining lower limbs and shoots to facilitate more detailed monitoring of crown health. All arisings should be contained and disposed of in a suitable manner and location for fireblight infected materials.

T268 - Platanus x hispanica (London Plane):

PRS - Prune from adjacent structure - to clear lamp column by 1.5 m also lightly tip prune low hanging branches to the east overhanging and encroaching upon the driveway to maintain a clearance of 4 m.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - o mark and name surrounding roads
  - o sketch in buildings, including adjoining properties
  - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - $\circ\;$  showing the approximate distance between the application tree(s) and buildings
  - $\circ\;$  adding other relevant features on the site (e.g. greenhouse, paths)
