(TPO REF; C345 2002) - CAR PARK AREA: 1 x Sycamore (G1) - Fell to ground level. (Northernmost tree closest to wall). 2 x Sycamores (G1) - Reduce crowns by 3m - 4m.

The Council has considered your application dated 12 July 2024 and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

1 This decision is valid for 2 years from the date of this decision or until the work is completed, whichever is the sooner.

Reason: To allow the Local planning authority to monitor the completion and standards of the work.

All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendation for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).

Between November 2024 and March 2025, a Liquidambar shall be planted in a location on-site that is a viable long-term location for the tree, (for example within the garden of the Pears building) as an heavy standard with a girth size of 12-14cm at 1m above the root collar, no less than 1m from structures unless otherwise agreed with the council in writing, The tree shall be planted and maintained in accordance with BS8545:2014 (Trees: from nursery to independence in the landscape – Recommendations).

Reason: In order to comply with s.206 of the Town and Council Planning Act 1990 (as amended).
