T1 London Plane - Lift crown over road to 6m, remove deadwood and hanging branches, Massaria inspection and infected branch removal.
T2 Lime - Crown reduce by 2-3m back to previous pruning points and remove epicormic growth.
T3 Beech - Reduce height of crown by approximately 3m.

T4 Sycamore - Crown reduce by 3m back to previous pruning points.
