## DECISION

Town and Country Planning Act 1990

### Advertisement Consent Granted

Proposal: Display of an externally illuminated fascia sign and a non-illuminated projecting sign.

Drawing Nos: Location plan; Existing Elevation Shop Front Rev. 1 dated 13/12/2023; Existing Elevation Shop Front Rev. 1 dated 06/12/2023; New Elevation Shop Front Rev. 1 dated 06/12/2023; Signage Detail Rev. 1 dated 06/12/2023; Section and proposed elevation Rev. 1 dated 06/12/2023.

The Council has considered your application and decided to grant consent subject to the following condition(s):

Conditions and Reasons:

- 1 No advertisement is to be displayed without the permission of the owner of the site or any other person with an interest in the site entitled to grant permission.

Reason: - As required by regulation 2(1) and Schedule 2 of the Town & Country Planning (Control of Advertisements) (England) Regulations 2007.

- 2 No advertisement shall be sited or displayed so as to
  - (a) endanger persons using any highway, railway, waterway, dock, harbour or

aerodrome (civil or military);

(b) obscure, or hinder the ready interpretation of any traffic sign, railway signal or aid to navigation by water or air; or

(c) hinder the operation of any device used for the purpose of security or surveillance or for measuring the speed of any vehicle

Reason: - As required by regulation 2(1) and Schedule 2 of the Town & Country Planning (Control of Advertisements) (England) Regulations 2007.

- 3 Any advertisement displayed and any site used for the display of advertisements, shall be maintained in a condition that does not impair the visual amenity of the site.

Reason: - As required by regulation 2(1) and Schedule 2 of the Town & Country Planning (Control of Advertisements) (England) Regulations 2007.

- 4 Any structure or hoarding erected or used principally for the purpose of displaying advertisements shall be maintained in a safe condition.

Reason: - As required by regulation 2(1) and Schedule 2 of the Town & Country Planning (Control of Advertisements) (England) Regulations 2007.

- 5 Where an advertisement is required under these Regulations to be removed, the site shall be left in a condition that does not endanger the public or impair visual amenity.

Reason: - As required by regulation 2(1) and Schedule 2 of the Town & Country Planning (Control of Advertisements) (England) Regulations 2007.

- 6 The fascia signage hereby approved shall be limited in illumination to 500 cd/m<sup>2</sup> and the illumination shall be static in nature.

Reason: To protect local amenity in accordance with policy A1 of the Camden Local Plan 2017.

#### Informative(s):

- 1 Reasons for granting permission:

This application seeks permission for the display of 1x externally illuminated fascia signage and 1x non-illuminated projecting sign. The fascia signage would be approximately 3500mm in width and 520mm in length and externally illuminated by an overhead trough-light in white light. The proposed projecting sign would be non-illuminated and approximately 500mm in length, 500mm in depth and 100mm in width. The site is located within the Camden Town Conservation Area, and is also within Camden Town Town Centre.

The proposed fascia sign and projecting sign would replace the existing ones and are considered acceptable in terms of size, number, position and luminance levels. The proposed projecting sign would be at fascia sign level. As such they would not appear out of proportion with the host building and streetscape. Submitted

drawings indicate that the illuminance level of the external trough-light would be below 500 cd/m<sup>2</sup> and this could be secured through a planning condition, which is appropriate in this location.

The signages would not impact on amenity in terms of light spill or outlook, nor would it be harmful to either pedestrian or vehicular safety. The signage therefore raises no public safety concerns. The application site's planning history was taken into account when coming to this decision.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the conservation area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

As such, the proposed development is in general accordance with Policies A1, D2 and D4 of the Camden Local Plan 2017, the London Plan 2021, and the National Planning Policy Framework 2023 and CPG Advertisements 2018.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraph 38 of the National Planning Policy Framework 2023.
